Agenda : 1. To confirm minutes of the previous meeting held on 20 October 2020.

The minutes of the previous meeting were read for the members and were confirmed unanimously.

2. Review of new courses started in previous academic session 2020-21.

Dr. Roshan Gaibe and Prof. Sandhya Fating presented on the successful execution of first batch of Advanced P.G. Diploma in Counselling which is due to appear for their final theory examination.

As for the newly started Diploma in Hospitality Studies, Prof. Akshay Dandale apprised the members that in the first part of this skill based diploma, all 29 admitted students appeared for online practical and theory examination and all passed with flying colours. The students shall be awarded diploma certificates post successful completion of individual industrial training.

Dr. Yogesh Gharpure, presenting for Diploma in Mass Communication and Journalism, and Diploma in Event Management stated that total 41 students were admitted and were successful in getting their respective Diplomas.

3. To consider new courses ^{for} diploma and certificates. Dr. Madhavi Paddada and Prof. V. Nair proposed the following diploma and certificate courses to be executed from the session 2021-22. The course contents alongwith time duration were presented before the members.

The members accepted the proposals and it was decided to be put before the Academic Council for its approval to the same.

4. To consider and approve changes in syllabi and directions.

Dr. S.S. Kabiraj proposed following modifications in the existing syllabus in the Subject Sociology for Bsw III Semester where he proposed to curtail some of the topic contents in all the four units.

As for the paper 'Social Problems and Social Disorganisation', a few topic contents were proposed to be curtailed.

In the Msw I Semester of Sociology paper also, a few topic contents were curtailed.

It was decided to put these changes before the Academic Council for the approval.

Dr. Shilpa Puranik apprised the members about changes proposed in Msw syllabus. As regards Msw I Semester, the topic 'National Social Work Council Bill' was added in the paper Perspective of Social Work Practice in India.

In semester IV, existing compulsory

paper 'NGO Management and CSR' was made optional while 'Disaster Management' is made compulsory paper in Semester III. In MSW III semester, nomenclature of paper 'Tribal Social System' is changed to 'Perspectives of Tribal Community Development'. As regards Directions leading to examination of MSW, some amendments were proposed relating to Scheme for Value Added Activities (VAA) and Incentives for Extra-Curricular Activities as follows :

ADDITIONAL MARKS

In addition to the regular courses the college also offers to its students an opportunity to earn extra marks and an improved grade through Value-Addition Activities (VAA) and the Extra-Curricular Activities (ECA). VAA and ECA have been given 2 credits (50 marks) each i.e. together they have 4 credits (100 marks).

These Grade marks will be added to the Cumulative Grade Score of all the Semesters and considered while calculating the Grade.

SCHEME FOR VAA (VALUE-ADDITION ACTIVITIES) MARKS -

Student will have to undertake at least one activity in each semester for a specific Field Action Project (FAP) so as to get marks given as per table. The marks shall be awarded by the respective in-charges based on active participation and report submission of the same to the in-charge of the FAP.
