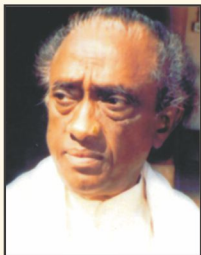

**About Parent Institution:**

Tirpude College of Social Work, Nagpur imparting education, training and research in the field of social work was established in 1966 by former Deputy Chief Minister of Maharashtra Shri Nashikrao Tirpude with an aim to impart quality education in the field of social work for the upliftment of the weaker section of the society. The Parent Body 'C. P. & Berar Depressed Class Society' was registered in the year 1922 for the upliftment of weaker sections of the society. It was renamed as 'Yugantar Education Society' in the year 1960 and was registered under the Society Registration Act 1860, and Public Trust Act 1951.

**Principal objective of Yugantar Education Society:**

To bring about socio-economic, educational upliftment of the depressed classes such as the Scheduled Castes, Scheduled Tribes and Other Backward Classes by protecting their just claims by all legitimate means.

**About College:**

Tirpude College of Social Work came into being on 1st July 1966. Tirpude College of Social Work is one of the pioneer institutes in central India imparting Social Work Education and Training, to create knowledge and value based society with a vision of inclusive and sustainable development through qualitative educational empowerment.

Tirpude College of Social Work has been awarded 'A+' grade by National Accreditation and Assessment Council constituted by University Grant Commission in the 3rd cycle of its reaccreditation in 2017. The college has previously been accredited with "A" grade in 2004 and 2011 by NAAC. It is the only college in the faculty of social work in Maharashtra State and R.T.M. Nagpur University, Nagpur having achieved 'A+' status as well as the only Social Work College in India that has been recognized as the college with Potential for Excellence by University Grants Commission, New Delhi in XIIth Plan. The college is permanently affiliated to R. T. M. Nagpur University and is recognized as a Place for Higher learning and Research. The name of college has been empanelled for evaluation of Govt. Scheme of Maharashtra.

The college is recognized by Ministry of Social Justice, Govt. of Maharashtra and University Grants Commission New Delhi. Tirpude College has formed a 'Sahyog' cluster as lead college joining with 09 other social work colleges under R.T.M. Nagpur University to share the curricular, co-curricular and others CSR activities by organizing inter collegiate sport, cultural and academic sharing such as seminar, workshops, conferences and research activities. The college has organized 12 national seminars sponsored by Indian Council of Social Science Research (ICSSR), University Grants Commission (UGC), New Delhi, in the collaboration with other social and academic organizations and self financed on various social issues such as farmer suicides, disaster management, scheduled caste, scheduled tribe, ageing, sustainable development goals, water security, pre marriage counselling, infatuation of love and so on. The college has contributed its services for the social cause at the local and national level and also contributed in framing policies for marginalised.

The college has Memorandum of Understandings (MOU's) with Fire and Security Association of India (FSAI), ANACONLAB, Nagpur, Govt. of Maharashtra State for evaluation.

The college is constantly working in the field of research. So far the college has conducted major & minor research projects sponsored by ICSSR and UGC on various important social issues from the year 2012-17. In extension activities the college include Child Guidance and Student Counselling Centre, PEACE project, N.S.S. unit of 150 students, Women Development Centre, and celebration of National and International Days, Birth and Death anniversaries of great leaders, social reformers of the Nation.

The college has well equipped Library, rich with e-resource, the college has Anti Ragging Cell, Committee Against Sexual Harassment, Equal Opportunity Cell, Placement Cell, Mentoring. The Faculty is highly competent and well qualified.

Acknowledging persistent academic excellence with National Accreditation and Assessment Council (NAAC) Bangalore affiliating the college with 'A' grades twice and with A+ in the third accreditation cycle, the University Grant Commission (UGC) has conferred 'Autonomous Status' to Tirpude College of Social Work making it the first social work college with autonomous status in Central India.

## **ELIGIBILITY**

Candidates who have passed certificate course in Social Work (CSW), Higher Secondary School Certificate examination (H.S.S.C.), Pre-University/ Pre-Degree or equivalent examination from a recognized Board/University are eligible for BSW course.

**BSW II<sup>nd</sup> year (III & IV Sem.) & III<sup>rd</sup> year (V & VI Sem.) will run as per old Pattern.**



**B) MASTER OF SOCIAL WORK (MSW) : 4 Semesters (2 yrs. programme)**

Candidates who have passed Bachelor's Degree examination in the subjects of Social Work, Arts, Science, Engineering, Medicine, Commerce, Pharmacy, Architecture, Home Science, Law etc. from Nagpur University or from any other University recognised by Nagpur University are eligible for admission to MSW course.

Application to the above courses may be made in the prescribed form. The form can be obtained from the college office directly. Normally, it is available during the months of May-June (Subject to Notification). The filled in forms with all the enclosures should reach the college office within the stipulated time. Delayed and incomplete forms are likely to be rejected.

**C) Ph. D. PROGRAMME :**

Student who have completed M.S.W./ M.Phil. in Social Work and cleared PET by the R.T.M. Nagpur University or NET SET exam are eligible for this programme. The course has capacity of 20 students only and admission will be subject to the vacancy in the center.

The activities of the Place for Higher Learning and Research center will be declared on the website of the college.

**1) Semester- I :** Centralized Admission process as per the directions of RTMN University, Nagpur. The candidate shall indicate their choice of field of specialization in the admission form. The Vacancy of the specialization are as follows-

Family and Child Studies (FCS) - 15	Human Resource Management - 10

**Note :** The specialization will be allotted strictly on the merit basis of MSW I Sem. examination. The specialization will be run if minimum 10 students are enrolled in it, however final decision regarding same shall rest with college authorities.

**2) Semester- II, III & IV :** Students who clear previous semester shall be eligible for admission in the next semester. Students shall be required to collect admission form from the office and submit on given time.

### A] THEORY:

#### Attendance :

1. Cent percent attendance in the theory classes is expected from the students. It is compulsory for all the students to have at least 75% of aggregate attendance in the theory classes as per the University rules.

### □ College Examinations :

4. The students must appear for all class tests, mid-term evaluation & Viva-Voce examinations .

#### **Following steps would be taken in case of low attendance percentage:**

- a) A warning letter will be issued to the students having attendance less than 75 %
- b) A letter of communication regarding attendance status of their ward will be dispatched to the parents/guardians whose attendance is less the 75 % and they may be called to discuss the matter personally with the authorities.
- c) Students having attendance below 75% may be liable for strict action to be decided by the Head of the Institution.

### **B] SOCIAL WORK PRACTICUM (FIELD WORK)**

1. Cent Percent attendance in Social Work Practicum is compulsory. All the students have to undergo training in various components of social work practicum.
2. If a student does not attend concurrent Social Work Practicum or visits due to any reason, he/she will have to inform the college social work Practicum incharge as well as Agency Supervisor in writing. Besides, he/she has to compensate the day's work with the consent of the Supervisors.
3. If a student does not attend the Social Work Practicum Components such as Observational Visits, Village Camp, Study Tour, Block Placement, Seminar, Paper reading etc, he/she will not be allowed to compensate for the same under any circumstances.
4. All the students must maintain a Social Work Practicum diary and they must obtain the signature of the Agency and College supervisors on each day's work. Details of the conferences with the Social Work Practicum Supervisors also must be entered in the diary and it must be submitted with the supervisors along with the Social Work Practicum reports, on a weekly basis.
5. The Social Work Practicum reports of the visits or the concurrent filed work, all in details, must be submitted with the concurrent Social Work Practicum supervisor on the first working day of the following week before 12.00 noon.
6. Responsible and mature behaviour in Social Work Practicum agency is expected from students
7. Under any circumstances, request for change in Social Work Practicum agency will not be entertained.
8. Students must attend the Social Work Practicum conference weekly, as per the instructions of the Social Work Practicum Supervisor.
9. Summer placements for MSW II Sem. and block placement for MSW IV will be compulsory.

### **C] DISSERTATION/GROUP RESEARCH PROJECT :**

1. A minimum of 10 Research Conferences with the research guide are compulsory.
2. A diary of the Research Conferences/work done must be maintained regularly by the students and the same must be duly signed by the respective Research Guides.
3. The last date of submission of dissertation with the college office will be declared by the

college . No dissertation submitted thereafter will be accepted by the college.

4. The cover page and the format of the dissertation must be as per the specifications given by the college.
5. Further detailed specifications are mentioned in the respective syllabi

**D] LIBRARY :**

1. In the absence of a teacher, students may avail the facilities of the library with permission of the Librarian.
2. All Library rules must be strictly followed by the students.
