IQAC External Peer Team Report

As per the request made by the college, the External Peer Review was conducted on 4th March 2021at 11.00 a.m. to monitorthe extent to which the measures for maintenance of standards in colleges with autonomous status as adopted and utilized by Tirpude College of Social Work (Autonomous).

The External Peer Review Team comprised of following members:

At the outset, the Management, Principal, HoD's and the faculty welcomed the peer team to the institution. The team interacted with the head, faculty and office staff of the college and had a review on the functioning of mandatory bodies and the documents pertaining to unique initiatives undertaken and transparent system adopted.

After taking overall view, the team has made following observations: -

 Tirpude College of Social Work was conferred with autonomous status by the UGC in March 2019 and the college adopted the autonomy from the session 2019-20.

The team personally interacted with the IQAC coordinator, heads of the departments, controller of examination, coordinators of various committees, office superintendent and has noted the positive impact in the functioning on account of fresh autonomous status.

- The IQAC coordinator introduced college and about the measures adopted for maintenance of quality.
- 3. In view of the stipulated UGC guidelines, following documents were examined to confirm the regularity in functioning of the mandatory bodies.
- i. NAAC Peer Team Review Report and the initiatives taken.

ii. Regular submissions of Annual Quality Assurance Reports (AQAR) till the session 2018-19.

iii.Minutes of meeting of statutory bodies such as Governing Body, Academic Council, Board of Studies, Finance Committee.

iv. Audited statements of expenditure of academic year 2019-20

v.Minutes of meetings of IQAC held periodically.

All the about documents are displayed on the college website.

- 4. The college has fulfilled all requisites by constituting all mandatory bodies. The members placed on such committees are placed in consonance with the UGC guidelines dated 19/01/2018 for autonomous colleges.
- 5. The new initiatives taken by the college are found to be in accordance with NAAC Peer Team report with a perspective plan for both short and long term. The IQAC is found to be proactive in introducing the best practice by taking efforts for their implementation.
- 6. The college houses a separate examination cell with a strong room. The unique initiative of exam system includes moderation of examined answer sheets, scrutiny process and declaration of results within 20 days after completion of examination. Examination is conducted under CCTV surveillance. Quality of Question papers and evaluation was found satisfactory.
- 7. The Board of studies of every department has framed syllabi with topics with relevance. The vision of the college is reflected in the redesigned syllabi.
- 8. The external Peer Team found that the student-teacher ratio is the issue of concern with sizeable number of vacancies of teaching as well as office staff. The college is suggested to address the issue on priority. In addition to the above observations, the college is equally proactive in promoting co-curricular, cultural, literary and social activities. The recognitions received by the students through their activities reflect the achievement of the college.
- 9. It is observed that the college, through the IQAC has studied the new education policy and planning to make efforts in its line.

The team, based on above observations is of the view that considering the fresh autonomous status conferred to

the college, notes that it has undertaken some discernable good practices and has been making sincere efforts to bring in measures for improving and maintaining the standards required in the autonomous college.

Overall, the team expresses satisfaction over the functioning of the college based on the observations made during the visit.
