This is with reference to the proposal submitted by Tirpude College of Social Work, Balasaheb Tirpude Marg, Civil Lines, Sadar, Nagpur-440 001, Maharashtra affiliated to Rashtrasant Tukadoji Maharaj Nagpur University, Nagpur under the UGC Scheme for Autonomous Colleges.

The Standing Committee in its meeting held on 16.01.2019 decided to grant autonomous status to Tirpude College of Social Work, Balasaheb Tirpude Marg, Civil Lines, Sadar, Nagpur-440 001, Maharashtra affiliated to Rashtrasant Tukadoji Maharaj Nagpur University, Nagpur for a period of ten years w.e.f. 2019-2020 to 2028-2029.


