












## Minutes of the Meeting of 19 Sept 2022.

Agenda 1 : To confirm minutes of the previous meeting of 28/9/21.

The minutes of the previous meeting held on 28 September 2021 were read for the members and were confirmed unanimously.

Agenda 2 : Review of academic activities during the session 2021-22.

Principal Dr. Swati Dharmadhikari apprised the members that all the academic activities were conducted in accordance with the annual plan. Two fresh diploma courses along with a certificate course (Certificate Course in CSR) were introduced during the session. The other



mandatory components in the MSW and BSW curricula - village camp and study tours were conducted successfully.

Agenda 3 : Restructure/revision of syllabi of BSW and MSW courses.

The Principal also stated that some outcome based changes were brought in as per the recommendations given in National Education Policy Document. Multiple entry - exit certificate scheme is introduced for the students pursuing BSW programme in the subject Business Communication, (English) in.

As regards syllabus of subsequent semesters of BSW and MSW programmes, it was clarified that the said changes have been brought in for the first semester only and for the remaining semesters, changes would be made in alignment with the Nagpur University's framework.

Agenda 4 : To consider and approve syllabi of newly proposed diploma courses.

Dr. D.R. Masram proposed to introduce a diploma programme, "Diploma in Social Entrepreneurship in Water Technology"; that was already passed in the previous meeting. However, the number of hours of course were altered from total 100 hours to 145 hours.

Mr. V. G. Nair introduced a new course

Certificate in Business Communication" of three months duration. After considering the fee structure and its utility for students, the course was cleared by the members to be tabled before the Academic Council for its approval.

Agenda 5: Any other matter.

As there was no additional matter left for discussion, the meeting was declared concluded with vote of thanks to the Chair and present members.
