"After considering the aspects such as effectiveness in functioning of the college, External Peer Team report of the previous session 2025-26, inadequate number of existing faculty and administrative staff and financial difficulties in terms of quantum of routine work to be executed for running an autonomous college, It is resolved that autonomous status of the college be surrendered with effect from the academic session 2026-2027 by following the procedure as laid down in the directions of the UGC!"

The Chairman directed the Principal to complete the necessary procedure in this regard.

The Principal informed the members that Dr. Shilpa Puranik, Senior faculty and member of the Governing Body is going to retire from her services in the college in the month of September due to age superannuation. The members thanked her for her valuable contribution to the institution.
