Sub. 1. Minutes of the previous meeting held on 21 April 2022 were read in front of present members and were approved.

Sub. 2. To consider and approve recommendations of Board of Studies.

At the outset, the new nominated members on the committee namely Dr. Anant Borde, Dr. Chandrashekhon Malviya and Dr. Vilas Ghode were introduced to the members by the Principal and welcomed.

if As recommended by the Board of Studies, the student of diploma course is unable to complete the entire course due to some genuine reason, he/she can have an opportunity avail certificate of that particular course, provided he/she undergoes some assessment in the form of assignments and deposits at least 50% fees prescribed for that diploma. The members, after due deliberations, accepted the proposal to be placed before the Governing Body.

Further, it was unanimously decided to stick with the existing contents and structure of the syllabus inclusive of ~~the~~ all language papers in BSW and MSW programmes.

Sub. 3 : To nominate two subject experts outside parent University on B o S.

After detailed deliberations, following persons were nominated as subject experts on Board of studies of the college for three years.

- 1) Dr. Dilip Barsagade from Gondwana University, Gadchiroli and
- 2) Dr. Tulsiram Rathod from Sant Gadge Baba Amravati University, Amravati.

Sub. 4 : To constitute awards on academic merit for students.

It was proposed by Hon'ble Principal that since the college collects alumni fund from each final year passing out student, cash academic awards of Rs. 3000/- for the topper and Rs. 2000/- for the second topper of BSW and MSW programmes respectively be constituted. Similarly, first two toppers from diploma and certificate courses run by the college be presented with a memento. The proposal was unanimously accepted.

Sub. 5 : Any other matter

Principal Dr. Swati Dharmadhikari informed the members that Maharashtra Knowledge Corporation Limited (MKCL) has offered to start center for computer courses for college students and the agreement regarding the same has been made. The members gave their consent for the course.
