- iii) In the subject Hindi, some parts of course contents in the syllabus of all the six BSW semesters were proposed to undergo partial changes pertaining to internal assessment, non-textual contents and rapid reading. The recommendation was approved to be placed before the Governing Body.

Sub 3 : To consider and approve new diploma course recommended by the Board of Studies :

The proposal to start new diploma course titled, 'Diploma in Social Entrepreneurship in Water Technology' was placed before the members. After examining its duration, unitwise contents and academic scope, the members, after due deliberations approved the course for recommendation to the Governing Body.
